This is the statement for your January 1, 2010 to December 31, 2010 dues and facilities charges. All dues are payable upon receipt of this statement and no refunds are permitted.

If proper paperwork is not submitted, your application will be returned to you. A complete application and payment must be received by February 1, 2010, or you will lose your boat slip or dock. After February 1<sup>st</sup>, your slip or dock will be reassigned. Bulkhead slips and private docks are not transferable. Stickers will be issued to members who own a car, boat or trailer and who have paid the appropriate fees and must be permanently affixed to your car, boat or trailer. Lost sticker charge is \$25.
